DESCRIPTION

This woodland was planted in the late 1990s with a mixture of native broadleaves and some conifers. The planting was carried out under a Woodland Grant scheme and a new owner will be responsible for taking on the liabilities of this scheme.

The wood, formerly quite fertile grazing land, has been very well planted with native broadleaves (ash, willow, alder, birch, cherry) including some clumps of conifers and Black walnuts planted in good, closely spaced lines. The trees have all grown very well and have just had their first thinning with 1 row in every 6 being removed to create access racks within the woodland. A new owner will be able to continue this thinning in due course and create reasonable volumes of firewood grade material every 10 years or so.

Further thinning will increase the light penetrating to the woodland floor and in time some of the native woodland indicator species could migrate from the older part of Gerbeston Wood.

Our first impression of the woodland was one of very fast growth in the young trees. The height and size that has been achieved already shows just how fertile the land is and how suitable it must be for growing timber.

Access

Access is via a gateway directly off the roadside, point B on the sale plan, which opens out into a small clearing in the southern edge of the wood. Access to the woodland is easy along the thinning racks that have been created throughout the crop.

Sporting rights are owned and included in the sale. They are not let.


METHOD OF SALE


