LOCATION

Situated within Snowdonia National Park, 5 miles west of Aberdovey and 6 miles east of Machynlleth. All distances are approximate.

GENERAL DESCRIPTION

Llwyn Celyn Woodland lies in a fantastic location and comprises an attractive mix of both broadleaved and conifer trees. The wood is of ancient origin meaning it is believed to have been continuously wooded since before 1600 AD.

Soils within the woodland are very fertile being freely draining acid loamy soils over rock and therefore favourable to tree growth. Existing tracks provide access into both lots.

The Lots comprise:-

LOT 1: LLWYN CELYN NORTH

12.88 acres / 5.21 hectares

Guide price: £65,000

Llwyn Celyn North is classified as a Restored Ancient Woodland Site. The woodland rises gently from the minor country lane on the north-western boundary to a ridge before falling towards the A493 on the eastern boundary.

Species comprise almost entirely of p1992 broadleaves, predominantly oak and birch with beech, alder, hazel and holly also featuring. A small area of p1969 larch can be found along the eastern boundary.

Access

Access is taken off the minor country lane to the north shown at point X on the sale plan. A track provides further access into this lot.

LOT 2: LLWYN CELYN SOUTH 11.48 acres / 4.65 hectares Guide price: £60,000

Llwyn Celyn South is classified as a Plantation on Ancient Woodland Site (PAWS). Situated on an east facing slope, the wood comprises p2014 Douglas fir in the western part and a mix of naturally regenerated and p2014 broadleaved species, predominantly oak and birch, in the remainder. Some p1880 oak also feature in the eastern part.

The Douglas fir is now established and growing well. Similarly, establishment of the broadleaves has been good but would benefit from some maintenance works which may improve their form.

Access

Access is taken off the A493 via a lay-by shown at point Y on the sale plan. From here a stone access track provides further access into the lot.

SPORTING AND MINERAL RIGHTS

Sporting rights are owned and included in the sales. They are not let. Mineral rights are owned and included in the sales.

FENCING

There is a fencing liability against agricultural land adjacent to lots 1 and 2 as shown with inward facing T-marks on the sale plan.






