LOCATION

Situated at Bishopstone, 2 miles north-west of Seaford and 3 miles east of Newhaven. All distances are approximate.

DESCRIPTION

Rookery Wood enjoys a fantastic setting within the South Downs National Park, just a stone's throw from the coast. The wood provides an exciting opportunity for a would-be purchaser to take on a restoration project and shape the future of the wood.

The property as a whole comprises Rookery Wood alongside a small area of pastureland and a pond.

The wood element accounts for the majority of the property and includes broadleaved species such as elm, ash and sycamore.

Broadly, the eastern part of the wood features maturing or mature trees whilst the western part features unmanaged natural regeneration.

The pastureland has previously been used for the grazing of horses and, alongside the pond, is in need of restoration.

Rookery Wood benefits from private vehicular access off Bishopstone Road, to the south-east of the property (shown as point X on the sale plan). From here private vehicular access into the wood can be taken along a path which runs along the eastern boundary of the property. This is shown with a broken brown line marked ABC on the sale plan.

We understand that direct access into the wood has also been taken through the pasture area. Access into the pasture area from Bishopstone Road is shown as point Y on the sale plan. Once restored this access could provide alternative access into the wood.




