LOCATION

Situated in an attractive location to the south of Clovelly, 18 miles south-west of Barnstaple and 47 miles west of Tiverton. All distances are approximate.

DESCRIPTION

Slade Wood is located within attractive Devonshire countryside just a stone's throw from the Hartland Peninsula and represents an excellent opportunity for a would-be purchaser to acquire a compact commercial woodland.

The wood comprises almost entirely of p2001 Sitka spruce but for a small band of mixed broadleaves on the northern boundary.

Broadly divided in two by a central ride, the northern half of the wood is well drained with the Sitka spruce showing excellent form and growth. In the southern half, although ground conditions are wetter, growth of the crop is still good. Yield classes across the Sitka range from 18 to 22.

Access to the wood is via the field to the north of the wood over the route shown ABC on the sale plan. A purchaser will be permitted to stone this track.

A purchaser will also be permitted to construct a stoned stacking area within the field, as shown shaded blue on the sale plan.

SPORTING AND MINERAL RIGHTS

Sporting rights are reserved to a former owner.

Mineral rights are retained by a previous owner.

FENCING

There are no known fencing liabilities.

RIGHTS OF WAY

The woodland is sold with the benefit of a right of way for all purposes with maintenance according to user over the route shown ABC on the sale plan allowing for the construction of a 6m wide track.


METHOD OF SALE


